CONFIDENTIALITY AND NONDISCLOSURE AGREEMENT

THE PARTIES:

This agreement is between

Bellamy (hereinafter referred to as "Disclosing Party")

and

AUCKLAND UNISERVICES LIMITED, a company organised under the Laws of New Zealand, having its registered office at Level 10, UniServices House, 70 Symonds Street, Auckland, New Zealand (hereinafter referred to as "Recipient").

WHEREAS:

The Parties wish to discuss confidential business and technical information of the Disclosing Party relating to an *exponential or vortexual motion machine* (the "Invention") so that they can discuss intellectual property strategy, whether to investigate the invention further, and/or bring the invention to the Return on Science investment committee. THE PARTIES AGREE AS FOLLOWS:

Definitions and Interpretations:

1. "Confidential Information" shall mean any and all information of the Disclosing Party in or relating to the invention, whether scientific, technical, trade, business or information of any kind, which is treated by the Disclosing Party as confidential, whether or not that information is labeled or stated to be confidential, subject to the proviso below. Without limitation, this information includes techniques, formulations, equipment, tests, data, text, reports, compilations, tables, drawings, sketches, know-how, sources of supply, patent position, relationships with consultants and employees, business plans and business developments, information concerning the scope or activities of research, development, manufacturing, marketing or other projects, samples and materials.

Providing that "Confidential Information" does not include information:

- a. already in the public domain prior to the date of disclosure by the Disclosing Party; or
- b. demonstrated from written records to have been in the Recipient's possession from another source, not under obligation of secrecy to the Disclosing Party, prior to disclosure by the Disclosing Party; or
- c. that subsequently becomes part of the public domain through no fault of the Recipient; or
- d. independently developed by the Recipient, as evidenced by written records, without the use of the Disclosing Party's Confidential Information.

Permitted Use

2. Confidential Information disclosed by the Disclosing Party to the Recipient may be used solely for the purpose of determining whether it is desirable to enter into a collaborative business relationship with the Disclosing Party, and for no other purpose.

Acknowledgment Regarding Proprietary Rights

3. The Recipient acknowledges that any and all proprietary rights in Confidential Information of the Disclosing Party belong to the Disclosing Party.

Nondisclosure of Confidential Information

4. Subject to clause 7 below, the Recipient shall not directly or indirectly publish, disseminate or otherwise disclose, deliver or make available to any third party (including subsidiaries, associated companies, joint venture parties or other associated organisations) any of the Confidential Information without the written consent of the Disclosing Party. Any disclosure to any third party, with consent, shall only be made under a written agreement with terms equivalent to those in this agreement.

5. The Recipient may only make Confidential Information available to its employees on a need to know basis. All such employees shall be made fully aware of the confidential nature of the information and shall sign a formal agreement with terms equivalent to those in this agreement.

6. The Recipient shall be liable for any breach of confidentiality by its employees.

7. A receiving party shall be entitled to disclose Confidential Information to the extent required by any applicable law, or by any judicial, Governmental or other official order, decree, regulation or rule, but only after written notification to the disclosing party of the requirement to do so specifying what Confidential Information is required to be disclosed, and to whom; and the receiving party shall take all reasonable steps necessary to ensure that any opportunity to challenge disclosure is preserved for the owner of the Confidential Information.

Duration

8. The obligations of confidentiality and non-use in this Agreement shall be binding throughout the term of this Agreement and shall remain in force for a period of five (5) years from the date of its expiration or termination.

Miscellaneous

9. Confidential information shall always be retained in a secure environment.

10. Upon termination of this agreement, the Recipient shall promptly, and within 5 working days, return to the Disclosing Party all originals and any copies of Confidential Information, and shall permanently delete all electronically or otherwise stored Confidential Information from all systems containing such Confidential Information, except that one copy may be retained solely as a measure of the Recipient's obligations hereunder.

11. The Disclosing Party warrants that it has the right to disclose any information that is disclosed under this Agreement.

12. The Disclosing Party gives no warranty, either express or implied, to the Recipient that any information disclosed:

- (a) is completely accurate; and/or
- (b) is useful in terms of this Agreement.

13. Any notice given under this agreement shall be in writing and shall be delivered in person, by courier service, by facsimile (provided that the sender's facsimile machine confirms transmission to the intended recipient), or by email (provided that the sender receives by email from the recipient, in the form of a return email or automatic confirmation message, confirmation of transmission to the intended recipient) addressed to the parties as follows:

14. The Recipient acknowledges that monetary damages alone may be an inadequate remedy for breach of the Recipient's obligations under this Agreement. In addition to any other remedy which may be available in law or equity, the Recipient agrees that the Disclosing Party shall be entitled to interlocutory injunctive relief to prevent any breach of this agreement.

15. This Agreement may not be amended, modified or revised except by a written instrument signed by an authorised representative of each party.

16. Nothing in this agreement shall be deemed to constitute, by implication or otherwise, the grant to the Recipient of any license or other interest in any proprietary rights of the Disclosing Party.

17. This Agreement shall not be assignable by either party without the written consent of the other party.

18. This Agreement shall be construed in accordance with the Laws of New Zealand and subject to New Zealand jurisdiction.

19. Should any provision of this Agreement be held by a Court to be unlawful, invalid, unenforceable or in conflict with any rule of law, statute, ordinance or regulation, the validity and enforceability of the remaining provisions shall not be thereby affected.

20. This Agreement is effective for a period of twelve (12) months from the date of execution of this agreement. The obligations of confidentiality and non-use survive expiration and termination.



FIELD OF INVENTION

- 5 This invention relates to the supply of energy. A particularly preferred embodiment relates to the supply of energy using a fluid which moves generally in the manner of a vortex.

BACKGROUND

- 10 It is desirable that energy be provided in an efficient manner, and it is an object of a preferred form of the invention to go at least some way towards facilitating this. However the object of the invention generally is not so specific, and is simply to provide the public with a useful choice.

SUMMARY OF THE INVENTION

15 According one aspect of the invention there is provided means for facilitating the supply of energy, having:

- a first blade arrangement adapted to spin and provide an inner vortex path;
 - a second blade arrangement adapted to spin and provide an outer vortex path;
 - 20 • a fluid which is able to circulate between the vortex paths; and
 - means for extracting energy (eg a spinning shaft or shafts);
- characterised in that blades of each blade arrangement are configured to cause high pressure and low pressure regions within each vortex path to at least facilitate movement of the fluid through the vortex paths, and wherein the means for extracting
- 25 energy can extract energy from the moving fluid, directly or indirectly.

Preferably the first blade arrangement is adapted to spin in an opposite direction to the second blade arrangement so that the fluid can circulate between the two vortex paths.

- 30 Preferably the first and second blade arrangements are configured to spin about a common axis.

Preferably the first blade arrangement is generally spherical (eg spheroid or an elliptical sphere).

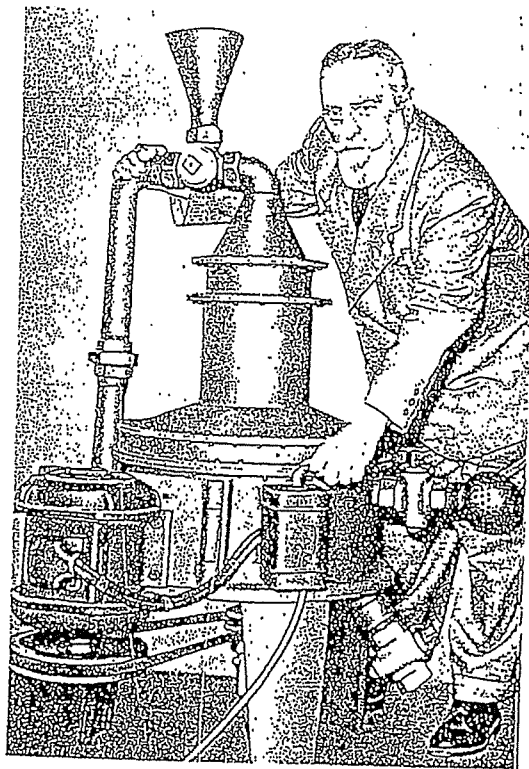


Fig. 1.3a The Home Power Generator.

Great to hear from you and irrespective of the terrible position you find yourself in, good luck with all your endeavours to clear your name. Just a point to note your letter turned up Friday (July 22nd) and yet I note you wrote it on the 10th of June. Clearly the prison mail system works at its own pace. I certainly hope this email gets to you quickly and finds you safe and well.

~~Previously, what occurred was a very big shock to everyone and especially my University of Auckland colleagues~~
 I am simply cannot be linked in any way with such a horrible situation. As such I have had to maintain a wait and see approach with respect to your energy technologies and I have been waiting for the dust to settle. I am delighted you are back thinking about next steps for ~~the energy technology~~ however I can only really help if we can agree on some kind of acceptable pathway and funding mechanism that will allow the right ownership structures to enable us to firstly progress a technically sound validation methodology and then subsequently a development pathway.

I can certainly follow up with the UoA team, however I can tell you, that you will not get a reply from any of the staff should you write directly. They simply will not get involved at this juncture, so please understand whilst you are in your current predicament, such non response is just reality. I will check out how to go about arranging a visit with you to have a catch up face to face? I believe this would be the most useful way and we can at least simply chew the fat around next steps and whether you would like my on-going assistance. I will call into the local corrections facility in Ulster Street to check out the procedure.

Finally, I am currently building a new boat, a Maritimo 48 fisher. Its 52 foot and about the same size as my old one (sold my old one a couple of months ago) so when you get out we can head off and catch some great snapper and akihi at Whanga. Who knows we may be able to also get a cray or two.

Good luck with all your travails, it's certainly a path that nobody would have wished upon you.

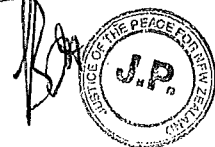

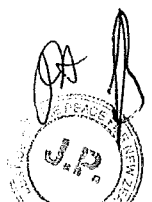



He advises that he has a boat moored at the Whangamata marina. That berth was hired from E26 Berth Limited. This company is owned by Tony BALLANTYNE and another person who he is unsure of the name, who he believed was a Fijian Indian. (Rajendra MONOHAN)

He first saw the berth for sale on Trade Me in October 2014. He made contact with the person and this was Tony BALLANTYNE.

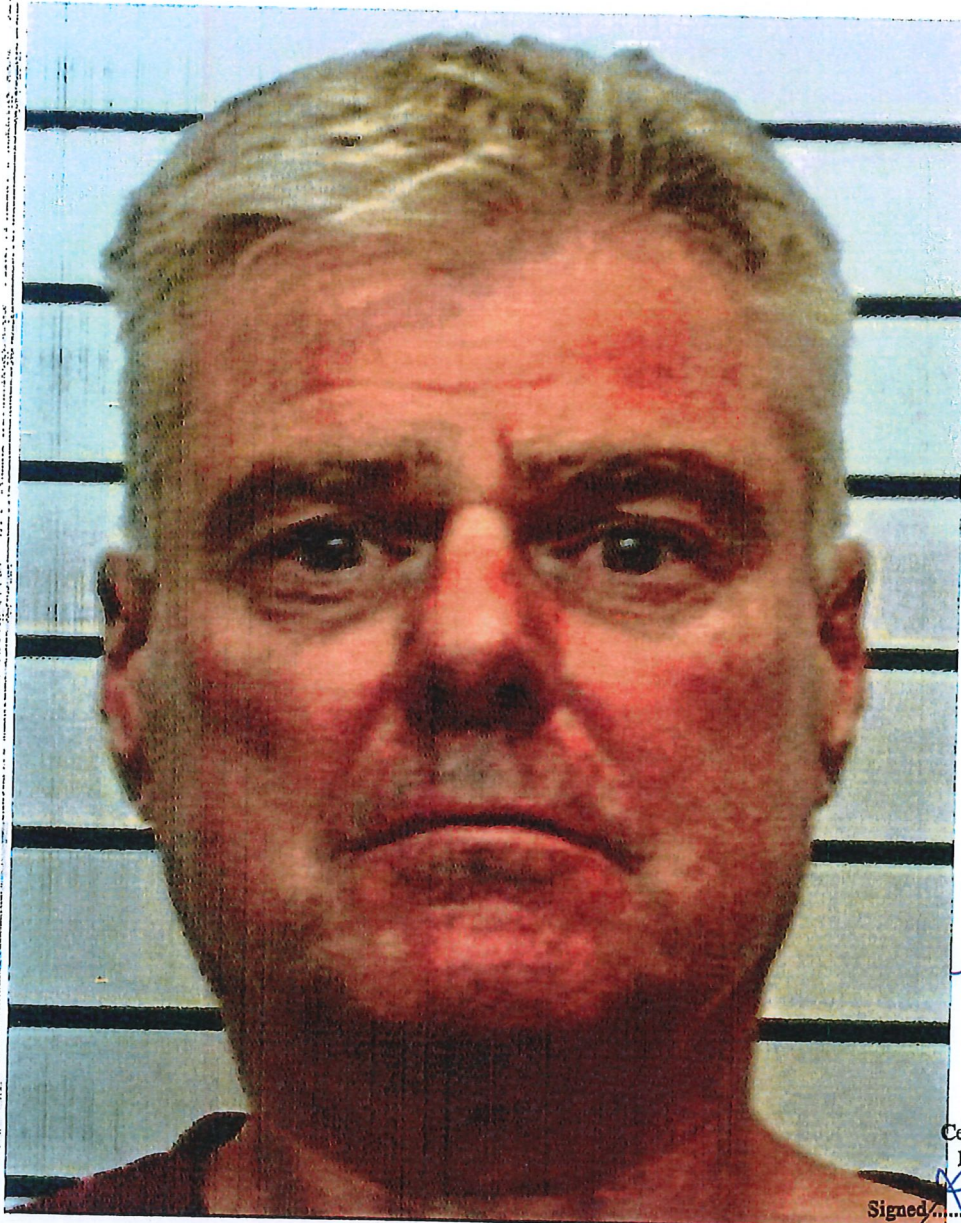
